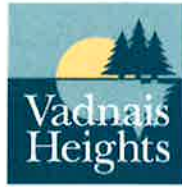

SUBJECT: For-Profit Solicitor's License – James Hardie Building Products/Services

Requested Council Action

Recommend the City Council consider approving the request by Tyler Barr for a For-Profit Solicitor's License to go door-to-door to residential properties for the purpose of selling James Hardie Building Products/Services beginning May 8, 2019-May 7, 2020, with the following conditions:

1. Activities shall follow the requirements of Chapter 10, Division 4, Peddlers, Solicitors and Canvassers, of the City Code;
2. The only persons allowed to solicit per the application request are Tyler Barr, Dakota Cossairt, Michael Nebel, Lukas Ramsey and Daniel Feneis;
3. The license is effective from May 8, 2019 through May 7, 2020; and
4. The hours requested to solicit and which are allowed by City Code are 10:00 a.m. to 6:00 p.m. (or dusk, whichever is earlier), Tuesday through Saturday.

Background

Tyler Barr of James Hardie Building Products has applied for a solicitor's license in Vadnais Heights. He has requested to go door-to-door to sell James Hardie Building Products/Services. The City has contacted the Ramsey County Sheriff's Department and requested they do a search on the applicant requesting to do this type of business as required by code.

Per the City Code an applicant is ineligible for this type of a license if they have been convicted within the past five years from the date of application, for any violation of any Federal or State statute or regulation, or of any local ordinance, which adversely reflects on the person's ability to conduct the business for which the license is being sought in an honest and legal manner or that will adversely affect the health, safety and welfare of the residents of the City. The check came back with no convictions, outstanding warrants or pending charges within the last five years. The fee for the soliciting license has already been paid.
