SUBJECT: Application for Renewal of Optional 2 AM Liquor License for Jimmy's Food & Drink

### **Recommended City Council Action**

Approve renewal of the Optional 2 a.m. Liquor License requested by Gerald, Inc. dba: Jimmy's Food & Drink at 1132 East County Road E, conditioned the application is approved by the State of Minnesota and that they follow guidelines approved originally by the City Council.

### **Background Information**

The application for the renewal of an Optional 2:00 a.m. Liquor License has been submitted by Gerald, Inc. dba: Jimmy's Food & Drink at 1132 East County Road E. The applicant has paid the State designated fee and a matching fee to the City of Vadnais Heights. They are also current with property taxes and city utility accounts and meet code requirements to have the Council consider this application and has also passed both their recent alcoholic and tobacco compliance checks administered by our police provider.

As part of the consideration in issuing the 2:00 a.m. optional license, previously the City Council did approve the restriction that the outside drinking/smoking area (patio area at Macaluso's) are allowed to have alcoholic beverages served in that location until 1:00 a.m. and those patrons may consume those beverages until 1:30 a.m., but then the patio area must be cleared. The facility's patrons may be served alcoholic beverages within the building until 2:00 a.m. and all persons except the owners or employees must be off the premises after 2:30 a.m. If approved, this application would be good for one year from the time the State also approves the license.

I would recommend approval of the application, conditioned the applicant follows the guidelines mentioned above.
