Nearly 30 years of residential land development experience, the last 20 years as the President of The Bancor Group, resulting in the development of over 2,500 lots in the Twin Cities. I was the President of various entities formed with other like-minded developers that developed several award-winning communities, which generated tens of millions of dollars of revenue.

Managed Newland's Minnesota office which included winding down its two current communities. Additionally, identifying and negotiating new locations for Newland's next master planned communities in the Twin Cities and obtaining their approval from Newland's Investment Committee. This includes preparing financial pro-formas, market research and site evaluation. Newland Communities is the nation's largest privately-owned residential land developer and is currently in 14 states.

Successfully negotiated an agreement to purchase 435 acres from the University of Minnesota. Then led the process of completing due diligence, directed a team (including AES) that developed a concept plan for the site and then obtained city approval for the concept. Unfortunately, the project was terminated in September 2019, when Newland's financial partner put on freeze on any new acquisitions in the U.S.

Owner and President of The Bancor Group, Inc., Shoreview, MN, 1999 to present.

Bancor has been involved in developing over 2,500 residential lots. In addition to identifying and developing communities, responsible for the administration and management of the company. This has included the recruiting, management, motivation and training of personnel, budgeting and financial management, identifying and securing capital investors, negotiating contracts, managing multiple contractors and managing legal services. A key part to Bancor's success is its reputation for integrity as well as skill in strategically navigating the process to successfully obtain simultaneously multiple governmental approvals and permits from multiple agencies.

- Bancor was the lead principal in the company that developed Wild Meadows, one of Minnesota's first conservation developments which has been recognized by the Minnesota Land Trust and the Sierra Club. This is where we first worked with AES.
- Bancor was one of the principals in the company that developed Locust Hills, the recipient of the Excellence in Development Award given by the Minnehaha Creek Watershed District. AES was involved in the design of this community.
- Bancor was the lead principal in the company that was awarded the development rights to redevelop downtown Mound that involved the remediation of a dump site.
- Currently Bancor is a principal in the company that is the development partner with Carlson Real Estate in developing Woodland Cove, 480 acres on Lake Minnetonka, which also was the recipient of the Excellence in Development Award given by the Minnehaha Creek Watershed District. This entitlement process involved securing and obtaining over 50 governmental permits from 17 governmental agencies and boards. AES was also involved in the design of this community.
