

SUBJECT: For Profit Solicitor's Permit – Legacy Restoration

Recommended Council Action

Recommend the City Council consider approving the request by Legacy Restoration for a For-Profit Solicitors License to go door-to-door to residential properties for the purpose of insurance inspector services, beginning September 8, 2021 through September 7, 2022, providing the following conditions must be met:


1. Activities shall follow the requirements of Division 4, Licensing and Registration of Peddlers, Solicitors, and Canvassers, of the City Code;
2. The only person allowed to solicit per the criminal history checks performed by Ramsey County is Cole Thurston.
3. The license is effective from September 8, 2021 through September 7, 2022; and
4. The hours allowed to solicit are 9:00 a.m. to dusk or 7:00 p.m. (whichever is earlier), Monday through Saturday.

Background

Legacy Restoration has already applied for and was granted solicitors permit in Vadnais Heights. They have been performing this type of activity in others areas of the metro area including New Prague, Elko New Market, Eagan, Rosemount, Apple Valley and St. Louis Park. Legacy has requested that five of their employees be allowed to go door-to-door to residential properties only to solicit from 9 a.m. until dusk or 7 p.m., whichever is earlier.

Per the City Code an applicant is ineligible for a license if they have been convicted within the past five years from the date of application, for any violation of any Federal or State statute or regulation, of and any local ordinance, which adversely reflects on the person's ability to conduct the business for which the license is being sought in an honest and legal manner or that will adversely affect the health, safety and welfare of the residents of the City. All the background checks came back with no violations.
