SUBJECT: For-Profit Soliciting/Peddlers License – Legacy Restoration

Recommended Council Action

If the City Council wishes to approve the request by Legacy Restoration LLC for a For-Profit Solicitor/Peddlers License to sell restoration services (roofing, siding, windows) for Legacy Restoration beginning March 22, 2023 through December 31, 2023, the following conditions must be met:

1. Passing a background check being performed by the Ramsey County Sheriff's office;
2. Activities shall follow the requirements of Section 10, Division 4, Licensing and Registration of Peddlers, Solicitors, and Canvassers, of the City Code;
2. The only persons allowed to solicit are: Trevor Devens;
3. The license is effective from March 22, 2023 through December 31, 2023; and
4. The hours allowed to solicit by City Code are 9 a.m. - 7:00 p.m.

Background

Legacy Restoration is located in Plymouth, Minnesota. The City has contacted the Ramsey County Sheriff's Department and requested they do a search on Trevor Devens as required by City Code. The background check came back with no violations over the past five years. Legacy Restoration is also licensed to solicit in the cities of Cottage Grove, Lakeville, and Woodbury.
